UPON ARRIVAL TO THE STUDIO ON YOUR FIRST DAY OF RENTAL YOU CAN EXPECT:

- A FRESHLY PAINTED COAT OF WHITE ON THE CYC WALL. OTHER COLORS OR TREATMENTS MUST BE COMMUNICATED WITH 2 WEEKS ADVANCED NOTICED & ARE SUBJECT TO ADDITIONAL MATERIALS COSTS.
- CLEANED & DISINFECTED FLOORS, SURFACES, AND AMENITIES.
- INTRODUCTION TO YOUR STUDIO ATTENDANT WHO WILL SUPPORT YOU THROUGHOUT YOUR RENTAL

HOURS AND OVERTIME:

- A STANDARD RENTAL COVERS A 10 HOUR DAY FROM THE START OF THE RENTAL PERIOD. START OF RENTAL PERIOD IS SPECIFIED BY THE CALL TIME OR WHEN THE FIRST MEMBERS OF CREW ARRIVE AND REQUEST ACCESS FOR LOAD IN OR SET UP.
- THE EARLIEST A RENTAL CAN START IS 7:30AM. ANY TIME BEFORE THAT IS SUBJECT TO THE EARLY ENTRANCE FEE OF \$150/DAY. IF YOU PLAN ON STARTING THE RENTAL PERIOD BEFORE 7:30AM YOU MUST INFORM PARTICLE 48 HOURS IN ADVANCE TO ALLOW FOR ADEQUATE STAFFING.
- THE LATEST A RENTAL CAN END IS 8:30PM. ANY TIME AFTER THAT IS SUBJECT TO THE LATE PRODUCTION FEE OF \$150/DAY. IF YOU PLAN ON ENDING THE RENTAL PERIOD AFTER 8:30PM YOU MUST INFORM PARTICLE 48 HOURS IN ADVANCE TO ALLOW FOR ADEQUATE STAFFING.
- THE RENTAL IS SUBJECT TO OVERTIME SHOULD ANY REMNANTS OF THE PRODUCTION BE IN THE SPACE AFTER THE 10 HOUR RENTAL PERIOD. THE OVERTIME RATE IS \$150/HR. OVERTIME HOURS ARE ROUNDED UP TO THE NEAREST HOUR AND NOT PRO-RATED BY THE MINUTE.

APPROPRIATE USE OF SPACES:

- PARTICLE DOES NOT ALLOW PAINTING INDOORS. IF YOUR PRODUCTION NEEDS AN AREA FOR SET BUILDING OR PAINTING YOU CAN UTILIZE THE BACK PARKING PAD OR IN CASES OF INCLEMENT WEATHER, THE LOADING BAY. IF YOU ARE IN NEED OF A BIGGER SPACE FOR PAINTING AND SET BUILD, SOUTHSIDE ALL-STARS IS A FABRICATION SHOP LOCATED NEXT DOOR. THEY'RE AWESOME AND WE WOULD BE HAPPY TO CONNECT YOU.
- WE EXPECT ALL PRODUCTIONS TO UTILIZE THE STUDIO AND ADJOINING SPACES FOR THEIR INTENDED PURPOSES ONLY. IF YOU WOULD LIKE TO ALTER THE USAGE OF A SPACE WITHIN THE STUDIO, PRIOR APPROVAL FROM A PARTICLE TEAM MEMBER IS NEEDED TO CONTINUE. ANY SPACE USED INAPPROPRIATELY AND OUTSIDE OF ITS INTENDED PURPOSE MAY BE SUBJECT TO A FEE.

DAMAGE AND INCIDENTALS:

- EXCLUDING ANY CYC WALL PAINTING, THE STUDIO MUST BE RETURNED TO ITS ORIGINAL STATE UPON COMPLETION OF THE RENTAL. THIS MEANS THE RENTAL IS RESPONSIBLE FOR AN ACCEPTABLE BASELINE CLEANING OF THE SPACE. SHOULD THERE BE DAMAGES OR ADDITIONAL CLEAN-UP INVOLVED FOR THE STUDIO, ADDITIONAL CLEANING FEES WILL BE ADDED TO YOUR FINAL INVOICE.
- WE DO NOT COLLECT AN INCIDENTALS DEPOSIT BUT WE DO REQUIRE A CREDIT CARD AUTHORIZATION TO BE HELD ON FILE FOR THE ENTIRETY OF THE BOOKING. THE CARD ON FILE WILL ONLY BE CHARGED IF THERE ARE DAMAGES THE PREMISES AND OR EQUIPMENT (INCLUDING LOSS OR THEFT DUE TO NEGLIGENCE). IN THE EVENT THAT DAMAGES OR LOSSES OCCUR WE WILL LINE ITEM OUT THE CHARGES FOR REPAIR OR RECOVERY ON THE FINAL INVOICE.

CANCELATION & RESCHEDULING:

- STUDIO RENTAL DATES ARE CONSIDERED "BOOKED" WHEN A 50% DEPOSIT OF RENTAL COSTS (NOT INCLUDING ADDITIONAL AMENITIES, GEAR, OR SERVICES) IS COLLECTED VIA A CREDIT OR DEBIT CARD PAYMENT EITHER VIA PHONE OR ONLINE. DEPOSITS CAN ALSO BE MADE VIA CHECK, CASHIERS CHECK, WIRE, OR ACH TRANSFER. IF YOU WOULD LIKE TO PAY WITH ANY PREVIOUSLY STATED METHODS, PLEASE CONTACT US FOR PAYMENT DETAILS.
